

**OFFICIAL RULES. NO PURCHASE NECESSARY TO ENTER OR WIN THE SWEEPSTAKES.
A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.**

1. **Sweepstakes Timing:** The PCA Skin Triple Technology Sweepstakes (the “**Sweepstakes**”) begins 9:00 a.m. Eastern Time (“**ET**”) on June 8, 2026 and ends at 11:59 p.m. ET on July 8, 2026 (the “**Sweepstakes Period**”).
